## Organ Transplant Initial Evaluation Notification

**Summary:** AmeriHealth Caritas Next/First Choice Next understands the importance of collaborating with our providers to provide specialized care for our members who may undergo an organ transplant. To begin planning for required care throughout the organ transplant process the health plan needs to be engaged as soon as possible. This begins with the initial evaluation and consideration for surgery.

Effective **January 5, 2026**, AmeriHealth Caritas Next/First Choice Next will require providers to submit notification of transplant evaluations. This notification will alert the health plan of the probability of an upcoming transplant procedure, activate care management planning, and coordination of required post-transplant or subsequent care to help ensure the best outcomes for our members.

### What will this mean for providers?

- Providers will submit the transplant evaluation notification via the NaviNet provider portal using the *Medical Authorizations* link, located under *Workflows for this Plan*.
  - Under *Service Type*, choose *Outpatient Transplant Evaluation* from the dropdown.
- Providers may also submit notifications by completing the Physical Health Prior Authorization form, located on our Prior Authorizations webpage. Fax completed form to **1-844-796-1177**.
- Medical necessity review will not be required for the initial evaluation.
- Medical necessity review will be required prior to the transplant procedure.
